1. POOLED

2. KAUBAD, NENDE HIND JA TELLIMISE KORD

Pooled on kokku leppinud, et Algoli müüdavad ja Kliendi ostetavad kaubad („Kaubad“), nende hinnad ja tellimise kord lepatakse kokku e-posti teel või muus kirjalikku taasesitamist võimaldavas vormis, kasutades Eritingimuste rekvisiitide osas märgitud kontaktandmeid.

Algoli pakutavad kaubad, nende hind ja pakutav kogus sisalduvad Hinnapakumises, mis vajadusel võidakse lisada Eritingimustele Lisana.

1. PARTIES

(a) „Algol Chemicals“ OÜ, company code 10036237, legal address: Väike-Paala tn 1, Tallinn 11415, Estonia (hereafter ”Algol”), and

(b) [Name], company code [●.....], legal address [●.....] (“Customer”).

The parties hereby enter into the agreement for the sale of industrial chemicals (the “Agreement”), consisting of these special conditions (the “Special Conditions”) and the general conditions (the “General Conditions”) which are available here: www.algolchemicals.com/company/documents.

Algol is entitled to amend the General Conditions and the Agreement will be subject to the version of the General Conditions in force at the time when Algol makes the offer for the delivery of Goods and is applicable without a separate written agreement between the Parties.

In the event of a conflict between the Special Conditions and the General Conditions, the Special Conditions shall prevail.

2. GOODS, THEIR PRICE AND ORDERING PROCEDURE

Parties agree on the goods that Algol will deliver to the Customer (“Goods”), their prices and ordering procedure, by exchanging e-mails or by agreeing otherwise in the form which can be reproduced in writing through the use of the contact information provided in the requisites part of these Special Conditions.

Description of Algol offered Goods, their price and amount offered, are shown in the Price Offer, which by necessity could be attached to Special Conditions in the form of Appendix.

3. DELIVERY TERMS AND PAYMENT CONDITIONS

The Goods shall be delivered on FCA as per Incoterms 2020:

unless the parties have agreed on a different delivery address. The time and date of delivery is agreed separately by both parties and it is provided in each order confirmation.

Parties agree that Customer will pay Algol invoices within **XX (in text)** days after the delivery has been accomplished from Algol’s side.

4. ALGOLI ESITATAVAD DOKUMENDID

Algol kohustub Kaupade müümisel andma Kliendile järgmised dokumendid: arve, saateleht ning analüüsisertifikaat, kui see on seaduse või poolte kokkuleppe kohaselt nõutav.

Leping on sõlmitud tähtajatult.
